having taken or subscribed the oath — required by the said Act, and having sworn — that he is a

Citizen of the United States, sole owner of the Ship or Vessel called the *Bolivar* of *Geddes* whereof the said *Enos P. Hubbard* is at present Master; and, as he hath sworn is a Citizen of the United States; and that the said Ship or Vessel was built in the State of New York, in the year one thousand, eight hundred and Twenty Six.

And *John Furman*, being thereunto appointed — having certified that the said Ship or Vessel has one Deck and no Mast and that her length is *Seventy six feet and eight inches* her breadth *Thirteen feet and eight inches* her depth *Two feet and two inches* and that she measures *Twenty one* tons, and *Thirty Three* ninty-fifth parts of a ton; that she is a *Boat* has no gallery and no head.
