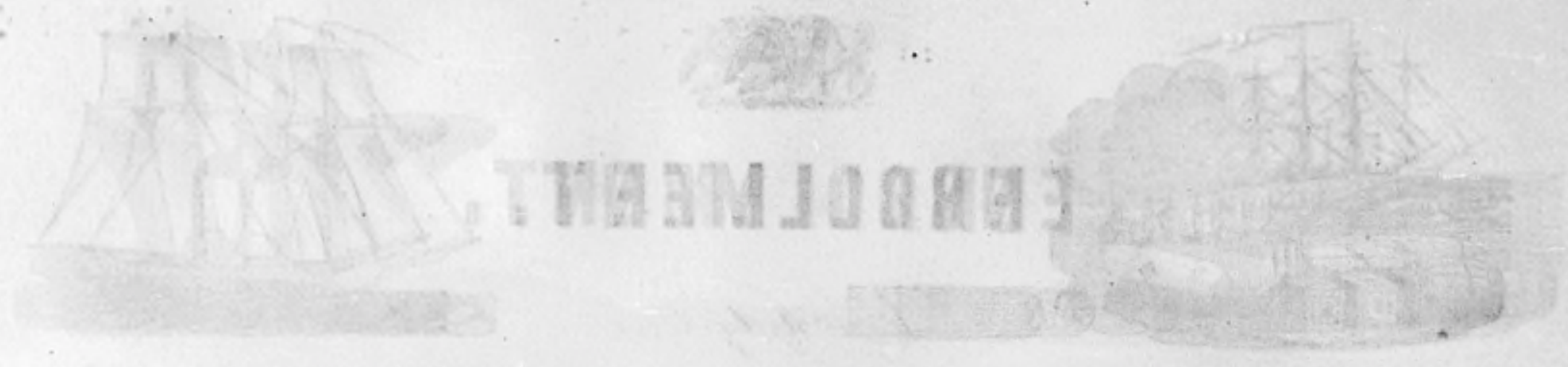

**IN CONFORMITY** to an Act of the Congress of the United States of America, entitled "*An Act for Enrolling and Licensing Ships and Vessels,*" &c. passed the 18th of February, 1793; and "*An Act to regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes,*" passed the 2d March, 1831. *John Rose of Buffalo NY*

having taken or subscribed the Oath required by said Acts, and having sworn that he *together with John W Strong Guardian of the Goods of Andrew J McKeogh and Judson C Stevens of Detroit Michigan and*

Citizens of the United States, sole owners of the *Schooner* \_\_\_\_\_ or Vessel called the *United States* \_\_\_\_\_ whereof *Sethu Peltus* \_\_\_\_\_ is at present Master; and, as he hath *sworn* \_\_\_\_\_ is a Citizen of the United States, and that the said Ship or Vessel was built at *Samsville Ohio* \_\_\_\_\_ in the year *1824* as appears by *New Enrollment dated at this Port the 11th day of May 1829* *now suspended having changed names* \_\_\_\_\_ And *The said Enrollment* \_\_\_\_\_ having certified that the said *Schooner* or Vessel has *One Deck* and *No Masts* \_\_\_\_\_ and that her length is *Sixty eight feet* \_\_\_\_\_ her breadth *Twenty one feet and five inches* \_\_\_\_\_ her depth *Seven feet and seven inches* \_\_\_\_\_ and that she measures *Ninety three* \_\_\_\_\_ tuns *of water* \_\_\_\_\_ ninety-fifths; that she is a *Schooner* \_\_\_\_\_ has *no galleries* \_\_\_\_\_ and \_\_\_\_\_ head. And the said *John Rose* \_\_\_\_\_ having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Schooner* \_\_\_\_\_ has been duly Enrolled at the Port of Buffalo Creek.
