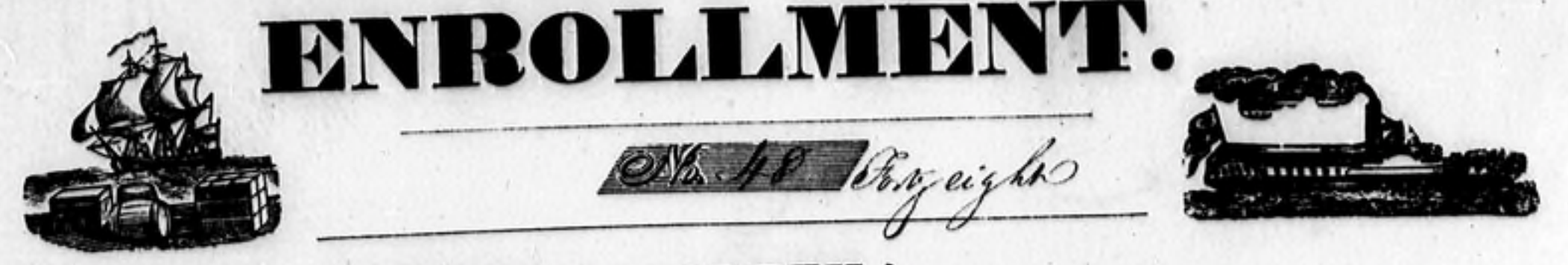

IN CONFORMITY TO

An act of Congress of the United States of America, entitled "an Act for Enrolling and Licensing Ships and Vessels," &c. passed the 18th February, 1793, and "an Act to regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed the 2d March, 1831, and "an Act to provide for the better security of the lives of passengers on board of vessels propelled in whole or in part by steam," passed 7th July, 1838.

*Peter L. Parsons of Buffalo N.Y.*  
having taken or subscribed the Oath required by the said Acts, and having sworn that he together with  
*Erasmus B. Robinson of the same place and Joel Bartholomew of Fairport Ohio*

**CITIZENS OF THE UNITED STATES** sole owners of the Schooner \_\_\_\_\_ or Vessel called the  
*Emory Fletcher* \_\_\_\_\_ whereof *Joel Bartholomew* \_\_\_\_\_ is at present Master; and, as he hath proven \_\_\_\_\_ is a  
Citizen of the United States, and that the said Ship or Vessel was built at *Fairports Ohio* \_\_\_\_\_ in the year 1845 as appears by *Her Enrolments* dated  
at the Port of *Cleveland* and the 30<sup>th</sup> day of *April* 1844. (Numbered 22, now surrendered having) *Changed* \_\_\_\_\_

And the said *Enrolments* \_\_\_\_\_ having certified that the said Schooner \_\_\_\_\_ or vessel has *One* deck \_\_\_\_\_ and *Two* Mast \_\_\_\_\_ and that her length is *Sixty nine* feet and *five* inches \_\_\_\_\_ her breadth *Nineteen* feet and *ten* inches \_\_\_\_\_ her depth *Six* feet and *Ten* inches \_\_\_\_\_ and that she measures *Eighty one* \_\_\_\_\_ tons *Twenty four* \_\_\_\_\_ ninety-fifths: that she is a Schooner \_\_\_\_\_ has no galleys \_\_\_\_\_ and a *Scull* \_\_\_\_\_ head.

And the said *Peter L. Parsons* \_\_\_\_\_ having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said Schooner \_\_\_\_\_ has been duly enrolled at the Port of Buffalo Creek.
