In conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels," &c., passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831; and "An Act to provide for the better security of the lives of Passengers on Great Vessels propelled in whole or in part by Steam," passed 7th July, 1838; and the Act of August 30th 1852 amending the same; also an act entitled "An act to provide for recording the conveyances of Vessels, and for other purposes," passed July 29, 1850.

Olinus Pugh of Buffalo N.Y. Managing Owner

having taken or subscribed the Oath required by said acts, and having sworn that he is a resident in the City of Buffalo N.Y. and is the Managing owner of the Brig J. R. Heddings of Buffalo and owns one equal undivided half part of the said Brig, and that Samuel L. Watson who resides at Buffalo N.Y. is the owner of the remaining equal undivided half part of said Brig J. R. Heddings of Buffalo, and that said vessel are both of them

Citizen of the United States, and sole owner of the *Brig J. R. Heddings of Buffalo* or Vessel called the *J. R. Heddings* whereof *S. L. Watson* is at present Master; and as he hath sworn Citizen of the United States, and that the said Ship or Vessel was built at *Ashtabula* State of *Ohio* in the year 1844 as appears by the last enrollment dated at this port *April 1855* now summed having changed name,

And the said enrollment the said *Brig* or Vessel has *One deck* and *Two masts* having certified that her length is *One hundred & fifteen* and that her breadth is *Twenty five feet and eight inches* and that she measures *Two hundred & fifty seven* tons *forty nine* and that she is a *Brig* has *ninety-fifths*

And the said *Olinus Pugh* and *head* agreed to the description and admeasurements above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Brig* has been duly Enrolled at the Port of Buffalo, N. Y. Given under my Hand and Seal of Office, at the Port of Buffalo, in the said District, this *11* day of *April* in the year one thousand eight hundred and fifty *five*
