

ENROLLMENT.

District of Buffalo Creek, PORT OF BUFFALO.

In conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c.," passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, Northeastern, and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to provide for the better security of the lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th 1852, amending the same; also an act entitled "An Act to provide for recording the conveyances of Vessels, and for other purposes," passed July 29th 1850.

A. J. Rich
having taken or subscribed the Oath required by said acts, and having sworn that he resides at Buffalo N. Y. in the District of Buffalo Creek, and is a

Citizen of the United States, and sole owner of the Schooner *Pitrel of Buffalo* whereof *A. J. Rich* is at present Master; and as he has sworn is a Citizen of the United States, and that the said Ship or Vessel was built at Buffalo N. Y. in the year 1847, as appears by the Certificate of his last Enrollment dated at this Port May 29, 1856 No 123 - now *Mundell* having changed owners,

And said Certificate the said Schooner or Vessel has *One* deck and *two* masts and that her length is *113* feet *10* inches her breadth *23* feet *4* inches her depth *8* feet *6 1/2* inches and that she measures *208* tons - *71* ninety-fifths that she is a *Schooner* has a *stern* head.

And the said *A. J. Rich* and *head* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said Schooner has been duly Enrolled at the Port of Buffalo, N. Y.
