And said Certificate the said Canal Boat or vessel has *one* deck and *no* mast and that her length is *94* feet — *6* inches her breadth *16* feet — *6* inches her depth *8* feet — *6* inches and that she measures *125* tons — *2* — ninety-fifths that she is a *Canal Boat* has a *square* stern and *no figure* head

And the said *John Pease* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Canal Boat* has been duly Enrolled at the Port of Buffalo, N. Y.
