In Conformity to an Act of the Congress of the United States of America, entitled, "An Act for Enrolling and Licensing Ships and Vessels, &c," passed 18th February, 1793; and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1833, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850.

having taken or subscribed the Oath required by said acts, and having sworn that he resides at *Buffalo NY* and that he is the owner of seven eighths part of the *Barque* *Chenango* of Buffalo and that *B J Wolow* who resides at *Cleveland State of Ohio* is the owner of one eighth part of said *Barque* and that they both are

Citizen of the United States, and sole owner of the *Barque Chenango of Buffalo* whereof *B J Wolow* is at present Master; and as he has sworn *thus he* is a

Citizen of the United States, and that the said Ship or Vessel was built at *Centago* State of *Ohio* in the year 1862, as appears by the *Certificate of his Temporary Register at the Port of Cleveland Ohio dated April 2 1862 number* *Ohio* now *surrendered* having arrived at his home port

And *Temporary Register* having certified that the said *Barque* of vessel has *one* deck and *three* masts and the her length is *137 7/100* feet *—* inches her breadth *26 7/100* feet *—* inches her depth *11 50/100* feet *—* inches and that she measures *Three hundred eighty four (384) tons* *fifty eight (58) ninety-fifths* that she is a *Barque* has a *Square* steam head. and *Plan*

And the said *Nathan C Winslow* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Barque* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
