In Conformity to an Act of the Congress of the United States of America, entitled, "An Act for Enrolling and Licensing Ships and Vessels, &c.," passed 18th February, 1793; and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850,

Windsor or Grand Rapids in the State of Michigan and that
he is a

Citizen of the United States, and sole owner of the *Scow A. Sullivans of Buffalo*

is at present Master; and as he has sworn *that he* is a

Citizen of the United States, and that the said Ship or Vessel was built at *Black River*
State of *Ohio* in the year *1854*, as appears by *the Certificate of his former*
Enrollment at this Port dated the 15 day of March 1861

And said Enrollment having certified that
the said *Scow* or vessel has *one* deck and *two* masts and the
her length is *76 1/2* feet *inches*
her breadth *18 1/2* feet *inches*
her depth *5 1/2* feet *inches*
and that she measures *Sixty one (61)* tons *thirty three (33) ninety-fifths*
that she is a *Scow* has a *square* steam
and *no fun* head.

And the said *James Goodell* having
agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms
of the said acts, the said *Scow* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
