In Conformity to an Act of the Congress of the United States of America, entitled, "An Act for Enrolling and Licensing Ships and Vessels, &c," passed 18th February, 1793; and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850,

having taken or subscribed the Oath required by said acts, and having sworn that he resides at *Chicago & Illinois*
and that *John W. Orthwein and Henry Doherty* reside at
Muskegon State of *Michigan* and that they are all

Citizen of the United States, ^{each of them being said owners} and sole owners of the *Schooner Dan Marble* of *Chicago* whereof *Thomas Doherty, James Marble* is at present Master; and as he has sworn *that he* is a

Citizen of the United States, and that the said Ship or Vessel was built at *Longport* State of *Ohio* in the year 1848, as appears by *the Certificate of her former Enrollment at the Port of Chicago* *dated the 30 day of June 1861* *number 61* *now running* *to and from* *having* *expired* *at this time from her home port*

And said Enrollment having certified that the said *Schooner* or vessel has *on* deck and *two* masts and the her length is *104* feet *2* inches her breadth *24* feet *10 1/2* inches her depth *9* feet *1 1/4* inches and that she measures *two hundred thirty three (233)* tons *sixty eight* ninety-fifths that she is a *Schooner* has a *steam* head.

And the said *Thomas Doherty* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Schooner* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
