Citizen of the United States, and that the said Ship or Vessel was built at *Corgan*
State of *Ohio* in the year *1847* as appears by *the certificate of his former enrollment at the Port of New York dated the 5 day of April 1860 number 12 now being having changed name to Detroit*

And said *enrollment* having certified that the said *Schooner* or vessel has *one* deck and *one* mast *5* and the her length is *117* feet *1* inches her breadth *26* feet *1* inches her depth *9* feet *11* inches and that she measures *two hundred seventy six (276)* tons *thirty three* ninety-fifths that she is a *Schooner* has a *square* steam head. and *a figure*

And the said *Edw. S. Hart* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Schooner* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
