In Conformity to an Act of the Congress of the United States of America, entitled, "An Act for Enrolling and Licensing Ships and Vessels, &c," passed 18th February, 1793; and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1835, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850,

Seth Clark

having taken or subscribed the Oath required by said acts, and having sworn that he resides at *Buffalo N.Y.*
and that *James Van Buren* resides at the same place
and that they both are

*Custom House,
Buffalo. July 16. 1866.*

*Surrendered and new papers issued,
having changed owners, and having been
remeasured.*

Each of our half part undivided *Brig Catalia* of
Citizens of the United States, and sole owners of the
Buffalo whereof *Francis V. Cook*
is at present Master; and as he has sworn *that he* is a

Citizen of the United States, and that the said Ship or Vessel was built at *Sandusky*
State of *Ohio* *rebuilt in the year 1862* in the year 1847 as appears by *the Certificate of her Enrollment*
at this Port dated May 15th 1862 number *60* *now surrendered*
having changed owners

And said Enrollment having certified that
the said *Brig* or vessel has *one* deck and *two* masts and that
her length is *119* feet *3* inches
her breadth *25* feet *6* inches
her depth *9* feet *6* inches
and that she measures *Two Hundred & sixty two (262) tons* *Sixteen (16) ninety-fifths*
that she is a *Brig* has a *Square* steam
and *no figure* head.

And the said *Seth Clark* having
agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms
of the said acts, the said *Brig* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
