In Conformity to an Act of the Congress of the United States of America, entitled, "An Act for Enrolling and Licensing Ships and Vessels, &c," passed 18th February, 1793; and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850,

Citizen of the United States, and sole owner of the *Schooner City of Milwaukee of Buffalo*
whereof *Thomas Andrew Neil Brown*
is at present Master; and as he has sworn *that he* is a

Citizen of the United States, and that the said Ship or Vessel was built at *Sharon*
State of *Ohio* in the year 1861, as appears by *the certificate of her former*
enrollment as the Port date the 17 day of June 1862
number 93 now surrendering Harry Chapin owner

And *said Enrollment* having certified that
the said *Schooner* or vessel has *one* deck and *three* masts and the
her length is *140 ³⁵/₁₀₀* feet inches
her breadth *29 ⁹⁴/₁₀₀* feet inches
her depth *11 ³⁴/₁₀₀* feet inches
and that she measures *four hundred thirty six ³⁴/₁₀₀ tons* fifty three *53* ninety-fifths
that she is a *Schooner* has a *Square* steam
and *no figure* head.

And the said *Charles Emig* having
agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms
of the said acts, the said *Schooner* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
