In Conformity to an Act of the Congress of the United States of America, entitled, "An Act for Enrolling and Licensing Ships and Vessels, &c," passed 18th February, 1793; and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1859.

Christian Brown Master of the Schooner Proria of Chicago
having taken or subscribed the Oath required by said acts, and having sworn that he resides at *Chicago Illinois and that Martin Olson who resides at Chicago owns 1/4 Barent Johnsen owns 1/4 B. & Olson 1/4 and Isaac Nilsen owns 1/4 and that they are all residents of Chicago Illinois and*

Citizen of the United States, and sole owner of the *Schooner Proria of Chicago* whereof *Christian Brown* is at present Master; and as he has sworn *in* is a

Citizen of the United States, and that the said Ship or Vessel was built at *Chicago* State of *Ohio* in the year *1855* as appears by *the Certificate of his last Enrollment at the Port of Chicago dated March 6 1862 numbered 12* now suspended having expired while from home port

And *Said Enrollment* having certified that the said *Schooner* or vessel has *one* deck and *two* masts and the her length is *113* feet *7* inches her breadth *24* feet *4* inches her depth *8* feet *11* inches and that she measures *Two hundred twenty six (226)* tons *four (4)* ninety-fifths that she is a *Schooner* has a *Square* steam head. and a *Scroll* head.

And the said *Christian Brown* having agreed to the description and measurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Schooner* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
