No. *Temporary*

In Conformity to an Act of the Congress of the United States of America, entitled, "An Act for Enrolling and Licensing Ships and Vessels, &c," passed 18th February, 1793; and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850,

*Edward Trimm* of Chicago Ill Master of the Schooner  
*Denmark of Chicago*  
having taken or subscribed the Oath required by said acts, and having sworn that he resides at *Chicago Illinois*  
and that *Sam Nye* who resides at the same place is a

Citizen of the United States, and sole owner of the Schooner *Denmark of Chicago*  
whereof *Edward Trimm*  
is at present Master; and as he has sworn

Citizen of the United States, and that the said Ship or Vessel was built at *Cleveland*  
State of *Ohio* in the year 1846, as appears by *the Certificate of her last*  
*Enrollment at the Port of Chicago dated April 15 1859*  
*numbers "15" now surrenders (having) expired while*  
*from some port*

And *said Enrollment* having certified that  
the said Schooner or vessel has *one* deck and *two* masts and the  
her length is *109* feet *11* inches  
her breadth *24* feet *12* inches  
her depth *9* feet *9* inches  
and that she measures *Two hundred and thirty six* tons & *63* ninety-fifths  
that she is a Schooner has a steam  
and a *small* head.

And the said *Edward Trimm* having  
agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms  
of the said acts, the said Schooner has been duly enrolled at the PORT OF BUFFALO, N. Y.

said District, this *six* day of *April* in the  
year one thousand eight hundred and *sixty three*
