In Conformity to an Act of the Congress of the United States of America, entitled, "An Act for Enrolling and Licensing Ships and Vessels, &c," passed 18th February, 1793; and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850,

*P. A. Reas of Chicago Illinois Master of the Brig - C. P. Williams of Chicago*  
having taken or subscribed the Oath required by said acts, and having sworn that he resides at *Chicago Illinois*

Citizen of the United States, and that the said Ship or Vessel was built at *Michigan City*  
State of *Indiana* in the year *1859*, as appears by *the Certificate of Her last*  
*enrollment at Chicago dated April 30 1861 and*  
*numbered 35 now surrendered having expired while*  
*from home port*

And *Said Enrollment* having certified that  
the said *Schooner* or vessel has *one* deck and *two* mast and the  
her length is *132* feet *7* inches  
her breadth *32* feet *3* inches  
her depth *11* feet *4* inches  
and that she measures *Four hundred and thirty four* tons & *3* ninety-fifths  
that she is a *Brig* has *No* gallery steam  
and *a figure* head.

And the said *P. A. Reas* having  
agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms  
of the said acts, the said *Brig* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
