In Conformity to an Act of the Congress of the United States of America, entitled, "An Act for Enrolling and Licensing Ships and Vessels, &c," passed 18th February, 1793; and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850,

having taken or subscribed the Oath required by said acts, and having sworn that he resides at *Buffalo N.Y.*
and is a

Citizen of the United States, and sole owner of the *Brig Mechanic*
of *Buffalo* whereof *Edward Collins*
is at present Master; and as he has sworn *that he* is a

Citizen of the United States, and that the said Ship or Vessel was built at *Detroit*
State of *Michigan* in the year 1848; as appears by *the Certificate of her Temporary*
Enrollment at the Port of Chicago dated the 14th day of
April 1863 and number 30 now *summed* having
arrived at home port

And said Enrollment having certified that
the said *Brig* or vessel has *one* deck and *two* mast & and that
her length is *124* feet *6* inches
her breadth *26* feet *5* inches
her depth *10* feet *4* inches
and that she measures *Three Hundred Sixty Six* tons *twenty Six* ninety-fifths
that she is a *Brig* has a *steam*
and a screw head.

And the said *Wm C Brown* having
agreed to the description and admittance above specified, and sufficient security having been given in conformity with the terms
of the said acts, the said *Brig* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**

said District, this *28th* day of *April* in the
year one thousand eight hundred and *sixty three*
