In Conformity to an Act of the Congress of the United States of America, entitled, "An Act for Enrolling and Licensing Ships and Vessels, &c.," passed 18th February, 1793; and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1855, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850,

J. J. Morris

having taken or subscribed the Oath required by said acts, and having sworn that he resides at *Cleveland Ohio* and owns one fourth ($\frac{1}{4}$) part and that *Nathan C. Winslow* resides at the City of New York and owns three fourths ($\frac{3}{4}$) and that they are all

Citizen of the United States, and sole owner of the *Schooner S. B. Pomeroy* of *Buffalo* whereof *J. J. Morris* is at present Master; and as he has sworn that he

is a *Cleveland* Citizen of the United States, and that the said Ship or Vessel was built at *Cleveland* State of *Ohio* in the year 1856 as appears by the Certificate of her former Enrollment at this Port dated the 3rd day of May 1862 and numbered "40" now surrendered having changed owners

And said Enrollment having certified that the said *Schooner* or vessel has *one* deck and *three* masts and that her length is *150* feet *100* inches her breadth *33* feet *34* inches her depth *11* feet *57* inches and that she measures *Five Hundred thirty one* tons *forty seven* ninety-fifths that she is a *Schooner* has a *square* steam head. and *figure*

And the said *J. J. Morris* having agreed to the description and admasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Schooner* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
