In Conformity to an Act of the Congress of the United States of America, entitled, "An Act for Enrolling and Licensing Ships and Vessels, &c," passed 18th February, 1793; and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1830, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 26th, 1850.

James G. Cheyne

having taken or subscribed the Oath required by said acts, and having sworn that he resides at *Milwaukie Wis* and that he is a *Citizen of the United States* and that *Charles H. Wheeler* resides at the same place and is a

Citizen of the United States, and sole owner of the *Schooner Acturus* of *Milwaukie* whereof *James G. Cheyne* is at present Master; and as he has sworn *that he* is a

Citizen of the United States, and that the said Ship or Vessel was built at *Huron* State of *Ohio* in the year *1853* as appears by *the Certificate of her former Enrollment at the Port of Milwaukie dated July 8th 1862 and numbered "2" now Sunnudee* *license having expired while from home port*

And *Said Enrollment* the said *Schooner* or vessel has *one* deck and *two* masts and the *her length is 140* feet *—* inches *her breadth 28* feet *4* inches *her depth 11* feet *3* inches and that she measures *Four Hundred & Twelve* tons *forty six* ninety-fifths that she is a *Schooner* has a *Square* steam head.

And the said *James G. Cheyne* and *Scroll* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Schooner* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
