In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c." passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, North-eastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "~~An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam~~" passed 7th July, 1838, and "~~the Act of August 30th, 1852, amending the same~~"; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels and for other purposes," passed July 29th, 1850,

State of *New York* in the year 18*63* as appears by *the Certificate of her last*  
*Enrollment, at this Port, dated August 27, 1863 and numbered '163'*  
*now surrendered having changed Owners*

And *said Enrollment*  
the said *Dug Prop'* or vessel has *one* deck and *no* mast and that  
her length is *38* feet *6* inches  
her breadth *10* feet \_\_\_\_\_ inches  
her depth *5* feet \_\_\_\_\_ inches  
and that she measures *Seventeen (17)* tons *Ten (10)* ninety-fifths  
that she is a *Dug Propeller* and *no figure* stern head.

And the said *Sho' Park*  
agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of  
the said acts, the said *Dug Prop'* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
