In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c." passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, North-eastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "~~An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam,~~" passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels and for other purposes," passed July 29th, 1850,

having taken or subscribed the Oath required by said Acts, and having sworn that he resides at *Painesville Ohio* and owns one third part ( $\frac{1}{3}$ ) and that *N. B. Bradley* resides at *Bay City Mich* and owns the remaining two thirds part ( $\frac{2}{3}$ ) and that they both are

Citizen of the United States, and sole owner of the *Dug Propeller Uncle Sam* of *Bay City* whereof *J. O. Woolson* is at present Master, and as he has sworn *he* is a

Citizen of the United States, and that the said Ship or Vessel was built at *Buffalo* State of *New York* in the year 1863 as appears by the Certificate of her last Enrollment at this Port, dated July 6<sup>th</sup> 1863 and numbered '139' now surrendered having changed Owners and District

And said Enrollment having certified that the said *Dug Prop* or vessel has *one* deck and *no* mast and that her length is *54* feet *6* inches her breadth *10* feet *11* inches her depth *4* feet *10* inches and that she measures *Twenty six* tons *29* ninety-fifths that she is a *Dug Propeller* has a *round* stern head and *no* figure

And the said *J. O. Woolson* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Dug Prop* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
