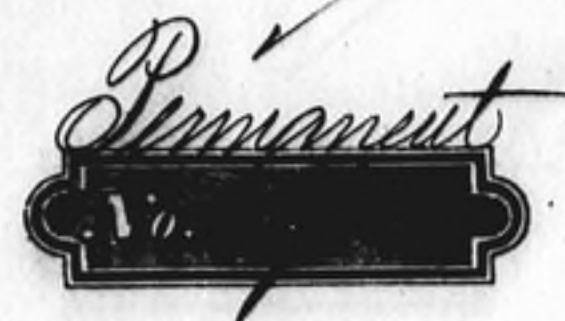

In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c." passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, North-eastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852 amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850,

*James Burns*  
having taken or subscribed the Oath required by said Acts, and having sworn that he resides at *Buffalo N.Y. and*  
*that James G. Gibney resides at the same place and*  
*that they both are*

*each one half part*  
Citizen of the United States, and sole owner of the *Brig Globe of Buffalo*  
whereof *James Burns* is a  
is at present Master; and as he has sworn *he*

Citizen of the United States, and that the said Ship or Vessel was built at *Buffalo*  
State of *New York* in the year *1844* as appears by *the Certificate of her Temporary*  
*Enrollment at the Port of Toledo Ohio, dated April 4th*  
*1864 and numbered 48" now surrendered having*  
*arrived at her home port*

And *said Enrollment*  
the said *Brig* or vessel has *one* deck and *two* masts and that  
her length is *113 1/2* feet *4* inches  
her breadth *25* feet *3 1/2* inches  
her depth *10* feet inches  
and that she measures *Three Hundred & nineteen* tons *seventy seven* ninety-fifths  
that she is a *Brig* has a *square* stern  
and *scrub* head.

And the said *James Burns*  
agreed to the description and measurement above specified, and sufficient security having been given in conformity with the terms of  
the said acts, the said *Brig* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**

District, this *18* day of *April* in the year  
one thousand eight hundred and sixty-*four*
