In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c." passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, North-eastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "~~An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam,~~" passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850

her length is *75* feet *6* inches
her breadth *16* feet *3* inches
her depth *10* feet *9* inches
and that she measures *One Hundred & nineteen* tons *ninety two* ninety-fifths
that she is a *Sug Propeller* has a *fan tail* stern
and *no figure* head.

And the said *H. G. Tisdale* having
agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of
the said acts, the said *Sug Prop* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
