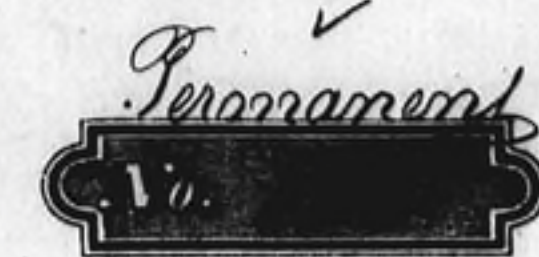

In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c." passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, North-eastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850,

Citizen of the United States, and sole owner of the *Sug Propr Joe Mac* of *Ogdensburg* whereof *he* is a

is at present Master; and as he has sworn Citizen of the United States, and that the said Ship or Vessel was built at *Buffalo* State of *New York* in the year 18*64* as appears by the Certificate of *C. A. Vanslyke* Shipwright, her builder, on file in this Office, and dated *May 3. 1864*

And *Sanford Halbert* surveyor appointed to measure said *Sug* having certified that the said *Sug Propr* or vessel has *one* deck and *no* mast and that her length is *56* feet *2* inches her breadth *12* feet *10* inches her depth *6* feet *6* inches and that she measures *Forty two (42)* tons *fifty two (52)* ninety-fifths that she is a *Sug Propeller* has a *fantail* stern head and *no figure* head.

And the said *David Bell* agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Sug Propr.* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
