In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c." passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, North-eastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850,

Sullivan* resides at *Chicago Ill.*, and owns the remaining *one eighth (1/8)*, and that they all are

Citizen of the United States, and sole owner of the *Barque R. G. Winslow* of *Buffalo* whereof *J. C. Sullivan* is at present Master; and as he has sworn *he*

Citizen of the United States, and that the said Ship or Vessel was built at *Cleveland* State of *Ohio* in the year *1857*, as appears by *the Certificate of her Temporary Enrollments at the Port of Chicago, dated April 14th 1864, and numbered "98", now surrendered, having arrived at home ports*

And *said Enrollment* having certified that the said *Barque* or vessel has *one* deck and *three* masts and that her length is *148 ⁸⁵/₁₀₀* feet *_____* inches her breadth *30 ³⁶/₁₀₀* feet *_____* inches her depth *11 ³⁶/₁₀₀* feet *_____* inches and that she measures *Four Hundred & ninety nine* tons *fifty five* ninety-fifths that she is a *Barque* and has a *square* stern head. *no figure*

And the said *Henry C. Winslow* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Barque* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
