In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c." passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, North-eastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels and for other purposes," passed July 29th, 1850.

Citizen of the United States, and sole owner of the Schooner *City of Chicago* of Buffalo whereof *David Lynn* of Buffalo is

is at present Master; and as he has sworn Citizen of the United States, and that the said Ship or Vessel was built at *Cleveland* State of *Ohio* in the year 18 *61*, as appears by the Certificate of her former Enrollment, at this Port, dated *August 5. 1862* and numbered *123* now surrendered having changed Owners

And *said Enrollment* the said *Schooner* or vessel has *one* deck and *three* masts and that her length is *140*^{*56*}/_{*100*} feet inches her breadth *30*^{*14*}/_{*100*} feet inches her depth *11*^{*26*}/_{*100*} feet inches and that she measures *Four Hundred & thirty seven* tons *fifty (50)* ninety-fifths that she is a *Schooner* has a *square* stern and a *figure* head.
