her length is *95* feet *—* inches
her breadth *17* feet *6* inches
her depth *6* feet *8* inches
and that she measures *One Hundred and three* tons *78* ninety-fifths
that she is a *Canal Boat* has a *round* stern
and *no* figures head.

And the said *D. D. Jackson* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Canal Boat* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
