In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c." passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, North-eastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1833, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850, and act of May 6th 1864.

Citizen of the United States, and that the said Ship or Vessel was built at *Buffalo* State of *New York* in the year 1856, as appears by the certificate of her former enrollment at this Port dated April 18th 1861 numbered "27" now surrendered vessel having been readmeasured under act of May 6th 1864.

And *Sanford Halbert* Surveyor having certified that the said Schooner or vessel has *one* deck and *two* masts and that her length is *130 3/10* feet *—* inches her breadth *28 9/10* feet *—* inches her depth *12* feet *—* inches and that she measures *Two Hundred and eighty nine* tons *8/100* ~~ninety~~ that she is a *Schooner* has a *round* stern and *no figure* head.
