In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c." passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, North-eastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1831, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same; also an Act entitled "An Act to provide for Recording the Conveyances of Vessels and for other purposes," passed July 29th, 1850, and Act of May 6, 1864.

*Bartholomen Mc Cabe*

having taken or subscribed the Oath required by said Acts, and having sworn that he resides at *Buffalo N.Y. and*  
that *Charles Jessimin* resides at the same place, and  
that they are

each one half *Scor* of the United States, and sole owner of the *Scor* of *Buffalo*  
whereof *Joseph Collin*

is at present Master; and as he has sworn is a

Citizen of the United States, and that the said Ship or Vessel was built at *Irving*  
State of *New York* in the year 1861, as appears by the Certificate of her last  
Enrollment at this Port dated *May 2<sup>o</sup> 1865* and  
numbered *103* now surrendered having changed owners

And *Said* Enrollment having certified that  
the said *Scor* or vessel has *one* deck and *two* masts and that  
her length is *93 7/10* feet *—* inches  
her breadth *22 7/10* feet *—* inches  
her depth *6 8/10* feet *—* inches  
and that she measures *One Hundred and five* tons *6/100* *—* ninety-fifths  
that she is a *Scor* has a *square* stern  
and *no figure* head.

And the said *Bartholomen Mc Cabe* having  
agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of  
the said acts, the said *Scor* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
