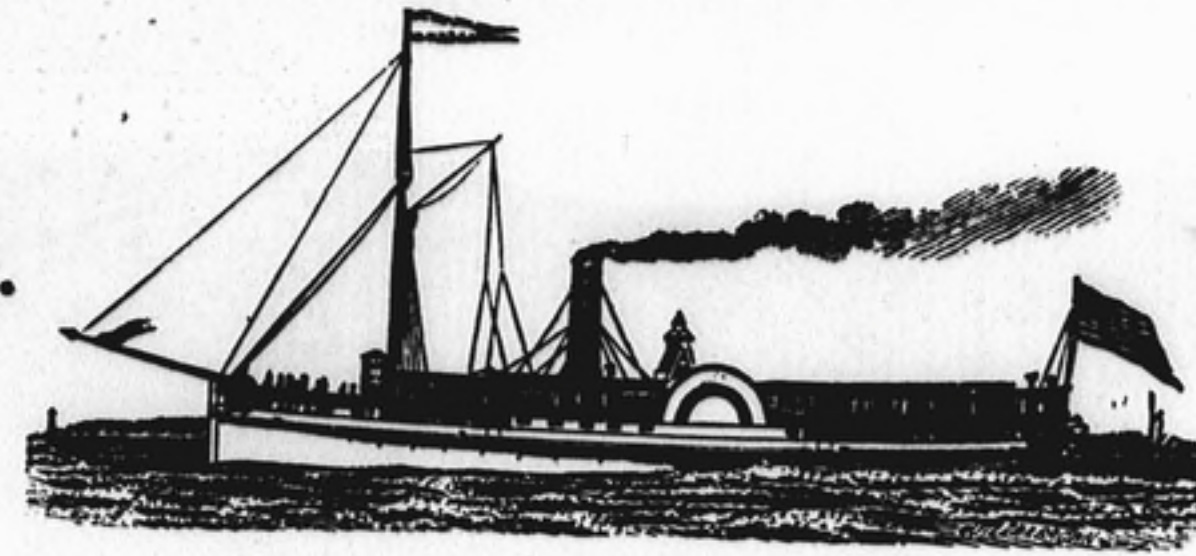


# ENROLLMENT.

In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c.," passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 23, 1801, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same, also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 20th, 1850, the 17th June 1864 and the act of the 7 July 1881

having taken or subscribed the Oath required by said Acts, and having sworn that he resides at *Buffalo N.Y.* and owns one half (1/2) and that *William Barr* and *John G. Barr* reside at the same place, and own one quarter each, and that they all are

Citizen of the United States, and sole owner of the *Tug Prop* or vessel called the *A.M. Ball* of *Buffalo* whereof *James Morgan* is at present Master; and as he has sworn *Tug Prop* is a Citizen of the United States, and that the said *Tug Prop* or Vessel was built at *Buffalo, N.Y.* in the year *1864* as appears by the *Certificate* of her last Enrollment at this Port, dated *March 20. 1866*, and numbered *27*, now surrendered, having changed Owners.

And *Said Enrollment* the said *Tug Prop* or vessel has *one* deck and *no* mast and that her length is *48 3/10* feet *no* inches her breadth *13 6/10* feet *no* inches her depth *6 4/100* feet *no* inches and that she measures *19* tons *8/100* ninety-fifths that she is a *Tug Propeller* has a *fan tail* stern and *no figure* head.

And the said *Nathaniel B. Hoyt* agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Tug Prop* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
