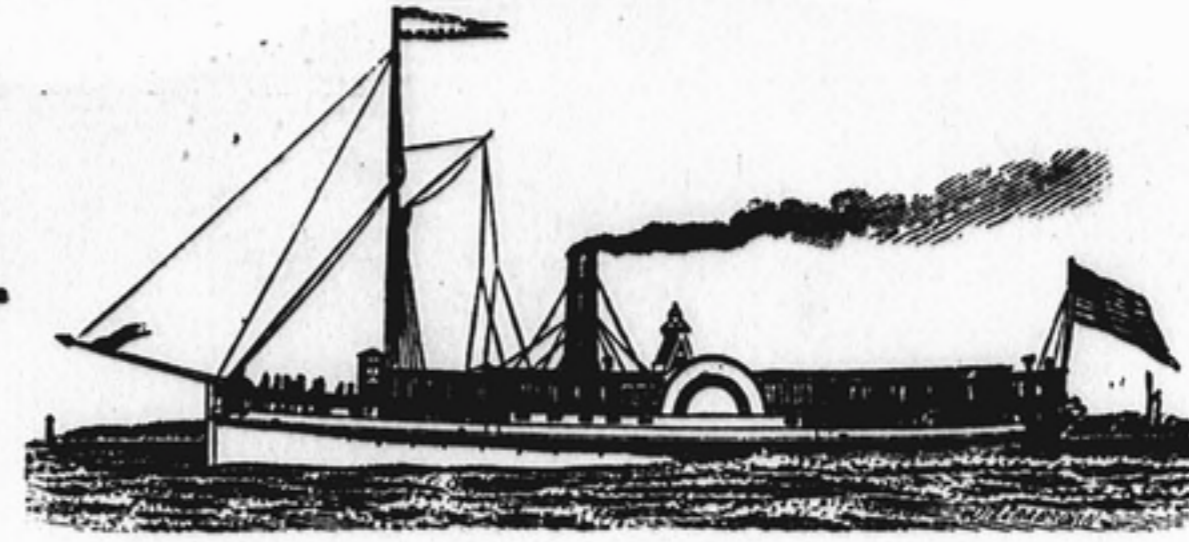

In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c.," passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 23, 1801, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 4th July, 1838, and the Act of August 20th, 1852, amending the same, also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 20th, 1850. *the 17th June 1864 & the Acts of the 7 July 1838*

*29 July 1850 & 6 May 1864*  
*Alvin Starkey*  
having taken or subscribed the Oath required by said Acts, and having sworn that he resides at *Buffalo N.Y.* and that he is a

Citizen of the United States, and sole owner of the *Schooner* or vessel called the *Mary Booth* of *Buffalo* whereof *John Hudson* is at present Master; and as he has sworn *Schooner* is a Citizen of the United States, and that the said *Ship* or Vessel was built at *Buffalo N.Y.* in the year 18*57*, as appears by *the Certificate of her last Enrollment at this Port, dated August 4, 1865, and numbered 288, now surrendered, having changed Owners & having Head Room added.*

And *Sanford Halbert* Surveyor having certified that the said *Schooner* or vessel has *one* deck and *two* masts and that her length is *100* feet *— inches* Capacity under tonnage decks *123.85* her breadth is *24 7/10* feet *— inches* Capacity of enclosures on upper decks *7.93* her depth is *6 2/10* feet *— inches* *131* tons *178 hundredths* *thirty-fifths* and that she measures *131* tons *178 hundredths* *thirty-fifths* that she is a *Schooner* has a *Square* stern and *no figure* head.

And the said *Alvin Starkey* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Schooner* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
