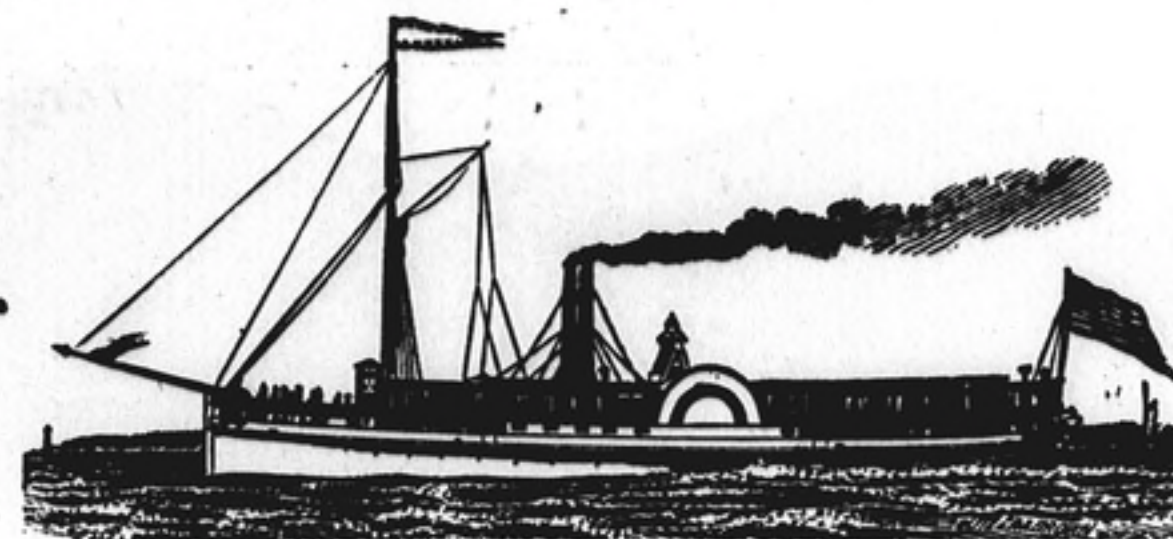

In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c.," passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 23, 1801, and "An Act to provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1808, and the Act of August 30th, 1858, amending the same, also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 20th, 1850. *The 17 June 1864 & the Acts of the 7 July 1858*
29 July 1850 & 6 May 1864.

Bartholomew McCabe

having taken or subscribed the Oath required by said Acts, and having sworn that he resides at *Buffalo N.Y.* and that *Charles Jefeman* resides at the same place, and that they both are

each one half
Citizen of the United States, and sole owner of the Schooner or vessel called the *Harriet Ross* of Buffalo whereof *Martin Malloney* is at present Master; and as he has sworn *Schooner* Citizen of the United States, and that the said Ship or Vessel was built at *Buffalo N.Y.* in the year *1854*, and ~~was~~ *rebuilt at Chicago Ill.* in the year *1854*, as appears by *the Certificate of her last Enrollment at the Port of Chicago, dated May 18, 1865, and numbered 339, now surrendered, having changed Owners & Dist.*

And *Said Enrollment* the said *Schooner* or vessel has *one* deck and *two* masts and that her length is *118 7/10* feet *inches* her breadth *23* feet *inches* her depth *10 7/10* feet *inches* and that she measures *179* tons *1/20 hundredths ninety-fifths* that she is a *Schooner* has a *Square* stern and *figure* head.

And the said *Bartholomew McCabe* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Schooner* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
