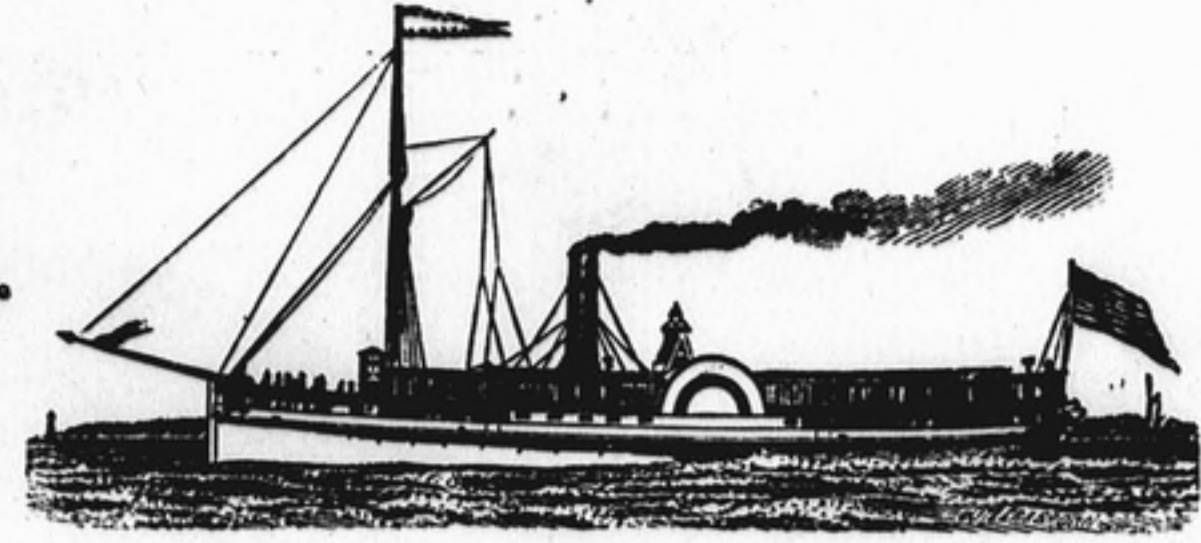

In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c.," passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1801, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same, also an Act entitled "An Act to provide for Recording the Conveyances of Vessels, and for other purposes," passed July 29th, 1850. *The 17 June 1864 & the acts of the 7 July 1838 & 29 July 1850 & 6 May 1864.*

having taken or subscribed the Oath required by said Acts, and having sworn that he resides at *Buffalo N.Y.* and that *Charles McKinstry* resides at the same place, and that they are

Citizen of the United States, and sole owner of the Schooner or vessel called the *Mary Ann Rankin*
of *Buffalo* whereof *Charles McKinstry*
is at present Master; and as he has sworn
Citizen of the United States, and that the said *Schooner* or Vessel was built at *Charlotte N.Y.*
State of *N.Y.* in the year *1867*, as appears by the Certificate of her last Enrollment
at this Port, dated *April 22, 1865*, and numbered *47*, now surrendered,
having *Head Room* added.

And *Sanford Walbert*, surveyor, having certified that
the said *Schooner* or vessel has *one* deck and *two* masts and that
her length is *90 2/10* feet *— inches* Capacity under tonnage decks *101.04*
her breadth is *20 5/10* feet *— inches* Capacity of enclosures on upper decks *4.14*
her depth is *8* feet *— inches* *105.18*
and that she measures *105* tons *18 hundredths*
that she is a *Schooner* has a *square* stern
and *no figure* head.

And the said *Michael Burns* having
agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the
said acts, the said *Schooner* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
