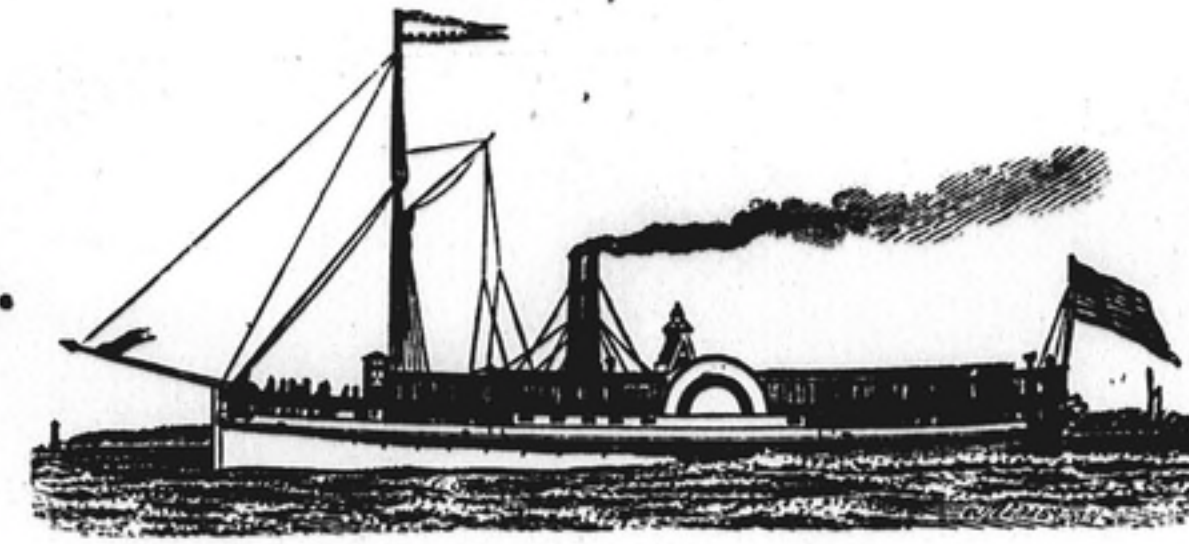

In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c.," passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 24, 1801, and "An Act to Provide for the better security of the Lives of Passengers on Board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 20th, 1852, amending the same, also an Act entitled "An Act to provide for Enrolling the Convoyances of Vessels, and for other purposes," passed July 20th, 1850, the 17 June & the Act of the 7th July 1838 & 29th July 1838 & 6th May 1854.

Citizen of the United States, and sole owner of the *Brig Rio Grande* of *Oswego* whereof *Felix Leonard* is at present Master; and as he has sworn *is a* Citizen of the United States, and that the said *ship* of Vessel was built at *Ogdensburgh, N.Y.* State of *New York* in the year 1856, as appears by the *Certificate* of her last Enrollment at this Port, dated *Oct 16, 1865*, and numbered *382*, now surrendered, having changed *Owners*, and having *Head room added*

And said *Brig* Enrollment having certified that the said or vessel has *one* deck and *two* masts and that her length is *116 7/10* feet *—* inches *(capacity under Foremast deck 194.46)* her breadth *24 4/10* feet *—* inches *(capacity of enclosure on upper deck 8.59)* her depth *10 7/10* feet *—* inches *293.05* and that she measures *203* tons *5/100* *ninety-fifths* that she is a *Brig* has *no galley* and *no figure* head.

And the said *Martin Golden* having agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the said acts, the said *Brig* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
