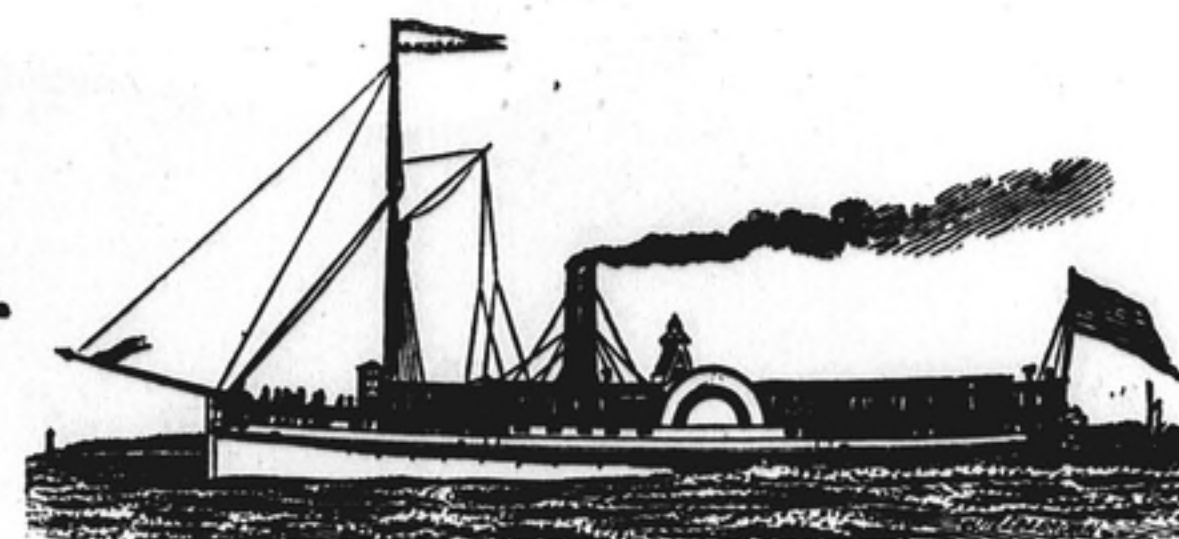

In Conformity to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships and Vessels, &c.," passed 18th February, 1793; and "An Act to regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed March 2d, 1821, and "An Act to Provide for the better security of the Lives of Passengers on board Vessels propelled in whole or in part by Steam," passed 7th July, 1838, and the Act of August 30th, 1852, amending the same, also an Act entitled "An Act to provide for Recording the Certificates of Vessels, and for other purposes," passed July 29th, 1850, the 17 June 1864 and the acts of the 7 July 1858

having taken or subscribed the Oath required by said Acts, and having sworn that he resides at *Buffalo N.Y. and*  
that he is a

Citizen of the United States, and sole owner of the *Sug Propeller Jenny Bell* of  
*Buffalo* whereof *he* is at present Master, and as he has sworn  
Citizen of the United States, and that the said *Sug Prop* or Vessel was built at *Buffalo N.Y.*  
State of *New York* in the year 1858, as appears by the Certificate of her last  
Enrollment at this Port, dated *Sept. 5 1865*, and numbered *321*  
*now surrendered, having changed Owners*

And *Said Enrollment* having certified that  
the said *Sug Prop* or vessel has *one* deck and *no* mast and that  
her length is *57 6/10* feet *—* inches  
her breadth *14 4/10* feet *—* inches  
her depth *6 3/4* feet *—* inches  
and that she measures *29* tons *4 9/100* hundredths  
that she is a *Sug Propeller* has a *round* stern  
and *no figure* head.

And the said *H. Mitchell* having  
agreed to the description and admeasurement above specified, and sufficient security having been given in conformity with the terms of the  
said acts, the said *Sug Prop* has been duly enrolled at the **PORT OF BUFFALO, N. Y.**
