sole owner of the Canal Boat or vessel called the D. H. Duggitt of Buffalo whereof he is at present Master, and as he hath sworn is a citizen of the United States, and that the said Canal Boat or vessel was built at Buffalo, N.Y. in the year 1865, as appears by the Certificate of her last Enrollment at this Port, dated August 15, 1866, and Numbered 194. Now surrendered having changed Owners and said Enrollment having certified that the said Canal Boat or vessel has one deck and no mast, and that her length is 95 feet her breadth 17 feet her depth 9 feet her height 7 feet and that she measures 124 tons and 74 hundredths,
