is a citizen of the United States, and that the said *Coast* or Vessel was built at *Rochester, N. Y.* in the year *1862*, as appears by *the Certificate of her last Enrollment at the Port of Rochester, N. Y. dated May 10, 1865 & Numbered 48. Now surrendered having changed* And *said Enrollment* having certified

that the said *Coast* or Vessel has *One* Deck and *No* Mast and that her length is *95* feet, her breadth is *17* feet, her depth *8* feet, her height *10* feet, and that she measures *114* Tons and *26* hundredths, viz:
