citizen of the United States, sole owner of the *Boat* Vessel called *Edward Delahunt* of *Buffalo* whereof *he* is at present Master, and as he hath sworn *he* is a citizen of the United States, and that the said *Boat* or Vessel was built at *Kept Vienna, N.Y.* in the year 1866, as appears by *the Certificate of Edward Delahunt her builder on file in said Office.*

And *Alonso H. Leiven, Surveyor* having certified that the said *Boat* or Vessel has *One* Deck and *No* Mast and that her length is *94* feet, her breadth is *17* feet, her depth is *7* feet, her height is *10* feet, and that she measures *115* Tons and *02* hundredths, viz:
