is a citizen of the United States, and that the said *Boat* or Vessel was built at *Buffalo, N. Y.* in the year *1869*, as appears by *the Certificate of Geo. H. Koster, shipwright her builder. On file in this Office.*

And *Alonzo Howard Scriver, Surveyor* having certified that the said *Canal Boat* Vessel has *One* Deck and *No* Mast and that her length is *95* feet, her breadth is *17* feet, her depth *8* feet, her height *10* feet,

and that she measures *119* Tons and *85* hundredths, viz:
