Enrollment in conformity to an Act of the Congress of the UNITED STATES OF AMERICA entitled "An Act for enrolling and licensing SHIPS OR VESSELS, &c." passed 18th February, 1793, and "An Act to regulate the Foreign and Coasting Trade on the Northern, Northeastern and Northwestern Frontiers of the United States, and for other purposes," passed the 17th June, 1864, and the Acts of the 7th July, 1838, 29th July, 1850, and 6th May, 1864.

is a citizen of the United States; and that the said *C. Boat* or Vessel was built at *Phoenix, N.Y.* in the year 18*66* as appears by *the certificate of her last Enrollment at the Port of Oswego, N.Y. dated July 25, 1868* renumbered *124* *now surrendered having changed District.*

And *said Enrollment* having certified that the said *C. Boat* or Vessel has *One* Deck and *No* Mast and that her length is *92* feet, her breadth is *17* feet, her depth is *8* feet, her height is *10* feet,

and that she measures *117* Tons and *18* hundredths, viz:
