as appears by *the Certificate of her last Enrollment at the Port of Rochester, N. Y. dated Decr. 1869 Cumberland Dist.* Now surrendered having changed Owners District.

And *said Enrollment* having certified that the said *Canal Boat* Vessel has *One* Deck and *No* Mast and that

her length is *94* feet,

her breadth is *17* feet,

her depth *10* feet,

her height *10* feet,

and that she measures *127* Tons and *74* hundredths, viz:
