IN CONFORMITY to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships or Vessels," &c., passed the 18th February, 1793, and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern, and Northwestern Frontiers of the United States, and for other purposes," passed the 2d March, 1831, and the Acts of the 7th July, 1838, 29th July, 1850, 6th May, 1864, and 17th June, 1864.

John F. Hagen of Buffalo, N.Y. having taken or subscribed the Oath required by the said Acts, and having sworn that he, ~~is a~~ *is a*

citizen of the United States, and sole owner of the *Banal Boat* vessel called the *Samuel Hardwell* *Buffalo* whereof *John F. Hagen* is at present Master, and as he hath sworn that he is a citizen of the United States, and that the said *Banal Boat* or vessel was built at *Buffalo, N.Y.* in the year 18*69* as appears by her *Temporary Register* issued at the Port of *Portsmouth, N.H.* dated *June 27, 1872* numbered *7*, *now surrendered vessel* having arrived at her home port, *Buffalo*, changed owners, and said Register having certified that the said *Banal Boat* or vessel has *one* deck and *one* mast, and that
