A. L. Lothridge of Buffalo, N.Y. having taken or subscribed the *Oath* required by the said Acts, and having *sworn* that he, together with *Abraham Nelson and Ann J. Russell of the same place, each own two Dwelphth (2/12)* and *that Frank Rockefeller of Cleveland, Ohio own six Dwelphth (6/12)* and that they all are

citizens of the United States, and sole owners of the *Barge* or vessel called the *Kellie McLibra* of *Buffalo*, whereof *A. L. Lothridge* is at present Master, and as he hath *sworn* that he is a citizen of the United States, and that the said *Barge* or vessel was built at *Buffalo, N.Y.*
