*H. Nelson Hann* of *Buffalo N.Y.* having taken or subscribed the *Oath* required by the said Acts, and having *sworn* that he, ~~is~~ *is a*

*citizen* of the United States, and sole owner of the *Canal Boat* or vessel called the *A. G.
