Joseph Snyder of Buffalo, N.Y. having taken or subscribed the Oath required by the said Acts, and having sworn that he, ~~is~~ is a

citizen of the United States, and sole owner of the Canal Boat or vessel called the *Sam J. Snyder*, of Buffalo whereof *Joseph Snyder* is at present Master, and as he hath sworn that he is a citizen of the United States, and that the said Canal Boat or vessel was built at Buffalo, N.Y.
