Wm Stamp of Buffalo, N.Y. having taken or subscribed the oath required by the said Acts, and having sworn that he, together with _____ is a

_____ citizen of the United States, and sole owner of the *Banal Boat* vessel called the *Gal. No. 100*, of Buffalo, whereof *Wm* Stamp is at present Master, and as he hath sworn that he is a citizen of the United States, and that the said *Banal Boat* vessel was built at *Lockport, N.Y.*
