IN CONFORMITY to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships or Vessels," &c., passed the 18th February, 1793, and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern, and Northwestern Frontiers of the United States, and for other purposes," passed the 2d March, 1831, and the Acts of the 7th July, 1838, 29th July, 1850, 6th May, 1864, and 17th June, 1864.

Mr. J. Russell of Buffalo, N.Y. having taken or subscribed the *Oath* required by the said Acts, and *sworn* that he, together with *Abraham Nelson and A. L. Lothrop of the same place*, are

 citizen of the United States, and sole owner of the *Canal Boat* vessel called the *D. A. Barton*, of *Buffalo*, whereof *Mr. J. Russell* is at present Master, and as he hath *sworn* that he is a citizen of the United States, and that the said *Canal Boat* vessel was built at *North Bay, N.Y.* in the year 1866 as appears by her last Enrollment at the Port of *Chicago, N.Y.* dated Oct 18, 1866 & numbered 229. *From which said* And *said Enrollment* having changed owners and having certified that the said *Canal Boat* vessel has *One* deck and *two* masts, and that her length is *95* feet, her breadth *17.8* feet, her depth *8* feet, her height *10* feet; that she measures *116* tons and *48* hundredths, viz.:
