IN CONFORMITY to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships or Vessels," &c., passed the 18th February, 1793, and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern, and Northwestern Frontiers of the United States, and for other purposes," passed the 2d March, 1831, and the Acts of the 7th July, 1838, 29th July, 1850, 6th May, 1864, and 17th June, 1864.

Joseph Patten of Buffalo, N.Y. having taken or subscribed the oath required by the said Acts, and having sworn that he, together with _____ is a citizen of the United States, and sole owner of the Canal Boat vessel called the Henry, of Buffalo whereof he is at present Master, and as he hath sworn that he is a citizen of the United States, and that the said Canal Boat vessel was built at Lockport, N.Y. in the year 1863 as appears by the Certificate of Charles D. Garner, Shipwright her builder, on file in this Office. And George G. Seriven, Surveyor having certified that the said Canal Boat or vessel has one deck and no mast, and that her length is 94 feet, her breadth 17 feet, her depth 7 feet, her height 7 feet; that she measures 102 tons and 72 hundredths, viz.:
