IN CONFORMITY to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships or Vessels," &c., passed the 18th February, 1793, and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern, and Northwestern Frontiers of the United States, and for other purposes," passed the 2d March, 1831, and the Acts of the 7th July, 1838, 29th July, 1850, 6th May, 1864, and 17th June, 1864.

John Beaynes of Buffalo N.Y. having taken or subscribed the oath required by the said Acts, and having sworn that he, together with \_\_\_\_\_ is a

Allen, of Buffalo whereof he is at present Master, and as he hath sworn that he is a citizen of the United States, and that the said Samal Boat vessel was built at Lockport, N.Y. in the year 1842 as appears by the Certificate of H. P. Brady shipwright her builder, on file in this office. And Alonzo H. Seaman, Surveyor having certified that the said Samal Boat vessel has One deck and two masts, and that her length is 96 feet, her breadth 14 feet, her depth 9 feet, her height 10 feet; that she measures 131 tons and 87 hundredths, viz.:
