Charles Ryan of Buffalo, N.Y. having taken or subscribed the *Oath*
 required by the said Acts, and having *worn* that she, ~~together with~~ *is a*

citizen of the United States, and sole owner
 of the *Canal Boat* vessel called the *John Hodge*, of *Buffalo*
