Samuel Gibson of Buffalo, N.Y. having taken or subscribed the Oath required by the said Acts, and having sworn that he, together with *Robert Craig* of the same place, each own *Three Eighths (3/8)*, and *John Gibson* of the same place, own *Two Eighths (2/8)*, and that they all are

citizen of the United States, and sole owner of the *Barge* or vessel called the *Richard J. Barney*, of *Buffalo* whereof *Russell P.
